

## Accidents and First Aid Policy

Updated in line with EYFS 2025, KCSIE 2025, and Working Together to Safeguard Children 2023.

At Ringle Rainbow Nursery, we aim to protect children at all times. We recognise that accidents or incidents may occur. This policy outlines the procedures for responding to accidents and injuries, ensuring appropriate first aid is administered, parents are informed, and safeguarding responsibilities are upheld.

### Accidents

The person responsible for reporting accidents, incidents, or near misses is the member of staff who witnessed the incident or was first to find the child. The incident must be recorded immediately on an Accident Form and shared with the nursery manager. Other staff may provide supporting statements. The parent must be informed and asked to sign the form on the same day or as soon as reasonably practicable.

The nursery manager reviews accident forms monthly to identify patterns (e.g., frequent accidents involving one child, or a recurring location/time). All necessary steps are taken to reduce future risk. Serious incidents are investigated, and a risk assessment is completed if needed.

The nursery manager will report serious accidents to the registered person, Ofsted, the local authority safeguarding team, or the Health and Safety Executive in line with RIDDOR requirements, within 14 days of the incident.

Accident records are stored securely in compliance with GDPR and retained for 21 years and 3 months.

### Head Injuries

If a child sustains a head injury, staff will assess and manage it using their first aid training, apply cold compresses if appropriate, and inform parents immediately. The child is kept calm and observed in a quiet area until collected. For serious injuries, NHS guidance is followed (<https://www.nhs.uk/conditions/minor-head-injury/>).

### Transporting Children to Hospital

In the case of a serious injury, staff will call 999. Parents will be contacted and asked to meet at the hospital. A staff member will accompany the child with relevant medical and registration information. Staff deployment will be managed to ensure continued supervision at the nursery.

### First Aid

First aid boxes are located in the kitchen and staff area, accessible to staff and regularly checked by the appointed person. They contain only approved items (sterile dressings, bandages, etc.). No medication is stored in these boxes. A list of paediatric first aid-trained staff is displayed in the nursery. A first aid-trained staff member will always accompany children on outings, with a first aid kit taken along.

As per EYFS 2025, at least one person with a current Paediatric First Aid (PFA) certificate is present at all times when children are on site or on outings. Newly appointed staff without PFA must be supervised at all times until training is completed.

### Food Safety and Play

Children are supervised during mealtimes. Food is cut to reduce choking risk. Food used for play is risk-assessed and differentiated from eating materials. Items such as playdough or dried pasta are presented separately. Children are supervised at all times.

### Personal Protective Equipment (PPE)

Staff must wear PPE during tasks involving bodily fluids to prevent cross-contamination. Blood spillages must be cleaned with gloves using sterilising fluid or diluted bleach (1:10). All waste must be disposed of safely and immediately.

### Needle Punctures and Sharps Injury

Any sharp object (needle, glass, etc.) found on-site must be treated as contaminated. Staff must wear gloves and report the item. Local authorities will be contacted for safe disposal. All such incidents are logged and assessed as potential safeguarding matters.

### Safeguarding and Reporting

All accident and first aid records are treated as safeguarding documentation. Staff monitor patterns or repeated injuries for signs of neglect or harm. Where safeguarding concerns arise, information is shared with the Designated Safeguarding Lead (DSL) and, if appropriate, external safeguarding agencies in line with Working Together 2023.

Digital accident logs are stored securely and comply with data protection and cybersecurity standards, in line with KCSIE 2025 guidance.

# Polish Policy (Polski) – First Aid

## Polityka Wypadków i Pierwszej Pomocy

Zaktualizowano zgodnie z EYFS 2025, KCSIE 2025 oraz Working Together to Safeguard Children 2023.

W Ringle Rainbow Nursery dążymy do zapewnienia bezpieczeństwa dzieci przez cały czas. Uznajemy, że mogą wystąpić wypadki lub incydenty. Niniejsza polityka określa procedury reagowania na wypadki i urazy, zapewniając udzielenie odpowiedniej pierwszej pomocy, poinformowanie rodziców oraz przestrzeganie obowiązków związanych z ochroną dzieci.

**Wypadki:** Osobą odpowiedzialną za zgłoszenie jest pracownik, który był świadkiem zdarzenia lub pierwszy znalazł dziecko. Zdarzenie musi zostać natychmiast zapisane w formularzu wypadku i przekazane kierownikowi. Rodzic musi zostać poinformowany i podpisać formularz tego samego dnia lub tak szybko, jak to możliwe.

Kierownik przegląda raporty miesięcznie w celu identyfikacji wzorców. Podejmowane są działania w celu zmniejszenia ryzyka. Poważne incydenty są badane, a w razie potrzeby sporządzana jest ocena ryzyka.

Poważne wypadki są zgłaszane do Ofsted, władz lokalnych lub HSE zgodnie z RIDDOR w ciągu 14 dni.

Dokumentacja przechowywana jest zgodnie z RODO przez 21 lat i 3 miesiące.

**Urazy głowy:** Personel ocenia uraz, stosuje zimne okłady i natychmiast informuje rodziców. Dziecko pozostaje pod obserwacją do momentu odbioru.

**Transport do szpitala:** W poważnych przypadkach dzwoniemy pod 999. Pracownik towarzyszy dziecku i przekazuje dane medyczne.

**Pierwsza pomoc:** Apteczki znajdują się w kuchni i pomieszczeniu personelu i zawierają zatwierdzone materiały. Przynajmniej jedna osoba z kwalifikacją PFA jest obecna w każdej chwili.

**Bezpieczeństwo żywności:** Dzieci są nadzorowane podczas posiłków, a jedzenie przygotowywane w sposób bezpieczny.

**Środki ochrony osobistej:** PPE stosowane przy kontakcie z płynami ustrojowymi. Rozlane płyny czyszczone zgodnie z procedurą.

**Ostre przedmioty:** Traktowane jako skażone i zgłaszane odpowiednim służbom.

**Ochrona dzieci:** Wszystkie zapisy traktowane jako dokumentacja ochrony dzieci.

# Politica privind accidentele și primul ajutor

Actualizată conform EYFS 2025, KCSIE 2025 și Working Together to Safeguard Children 2023.

La Ringle Rainbow Nursery protejăm copiii în orice moment. Recunoaștem că pot apărea accidente sau incidente.

Accidente: Membrul personalului care a observat incidentul trebuie să îl înregistreze imediat și să informeze managerul. Părinții trebuie informați și să semneze formularul în aceeași zi.

Managerul analizează lunar incidentele pentru a identifica tipare și a reduce riscurile.

Incidentele grave sunt raportate către Ofsted, autorități locale sau HSE conform RIDDOR în termen de 14 zile.

Înregistrările sunt păstrate conform GDPR timp de 21 ani și 3 luni.

Lovituri la cap: Copilul este evaluat, se aplică comprese reci și părinții sunt informați imediat.

Transport la spital: Se apelează 999, iar un membru al personalului însoțește copilul.

Prim ajutor: Trusele sunt disponibile și conțin doar materiale aprobate. Personal cu calificare PFA este prezent permanent.

Siguranța alimentelor: Copiii sunt supravegheați în timpul meselor.

Echipament PPE: Utilizat pentru prevenirea contaminării.

Obiecte periculoase: Tratate ca fiind contaminate.

Protecția copilului: Toate înregistrările sunt documente de protecție.

Contacte: Ofsted, autorități locale, HSE.

Политика за инциденти и първа помощ

Актуализирана съгласно EYFS 2025, KCSIE 2025 и Working Together to Safeguard Children 2023.

В Ringle Rainbow Nursery защитаваме децата по всяко време.

Инциденти: Служителят, който е свидетел, трябва незабавно да регистрира инцидента и да информира мениджъра. Родителите подписват формуляра същия ден.

Мениджърът преглежда инцидентите ежемесечно за намаляване на риска.

Сериозните инциденти се докладват до Ofsted, местните власти или HSE в рамките на 14 дни съгласно RIDDOR.

Записите се съхраняват съгласно GDPR за 21 години и 3 месеца.

Травми на главата: Детето се наблюдава и родителите се уведомяват незабавно.

Транспорт: Обаждане на 999 и придружаване от служител.

Първа помощ: Комплектите съдържат одобрени материали. Персонал с PFA е наличен постоянно.

Безопасност на храните: Децата са под наблюдение.

ЛПС: Използват се за защита.

Остри предмети: Считат се за опасни.

Закрила на детето: Всички записи са защитна документация.
